OF THE MONROE COUNTY COMMISSIONERS ON BEHALF OF EAST STROUDSBURG BOROUGH COUNCIL FOR BUDGET
MODIFICATION TO THE BOROUGH'S FEDERAL FISCAL YEAR 2016 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
PROGRAM

Notice is hereby given that the Monroe County Commissioners on behalf of the East Stroudsburg Borough Council will hold a public hearing on **Wednesday, September 19, 2018 at 9:30A.M.** at the Administrative Center, 1 Quaker Plaza, Stroudsburg, PA 18360. Subsequent to the September 19, 2018 public hearing, the Monroe County Commissioners, will consider adoption of a Resolution authorizing the County on behalf of the Borough, to submit said modification documentation to PA-DCED for approval, contingent on adoption of a Resolution by the East Stroudsburg Borough Council. The East Stroudsburg Borough Council will consider the adoption of a Resolution authorizing the County to submit said modification documentation to PA-DCED at their **Tuesday, September 18, 2018 at 7:00P.M.** Borough Hall, located at 24 Analomink Street, East Stroudsburg, PA 18301.

The purpose of the public hearing is to receive citizens' views, comments and suggestions or other information from the public, for consideration by the Monroe County Commissioners on behalf of East Stroudsburg Borough Council, prior to modifying the 2016 Borough's CDBG program budget. Additionally, citizens may also comment on the Borough's prior use of CDBG funds.

The range of activities which may be undertaken with CDBG funds include but are not limited to benefiting low and moderate income persons through various eligible activities, meeting an urgent need as identified by the community, and preventing and eliminating slum and blight.

The purpose of the modification for the 2016 budget involves the reduction of the Curb-cut ADA Ramp Project in the amount of \$13,916.74 and the creation and funding of the Demolition project in the amount of \$13,916.74.

The public is encouraged to attend and participate in the hearing and meeting. Written and oral comments are encouraged and can be directed to Martha A. Robbins, Executive Director, Redevelopment Authority of the County of Monroe, 701 Main Street, Suite 502, Stroudsburg, PA 18360. All comments regarding the modification and the Borough's prior use of CDBG funds must be received by **Tuesday, September 18, 2018**. Pursuant to approval by the East Stroudsburg Borough Council and the Monroe County Commissioners on behalf of the East Stroudsburg Borough Council and after consideration of all comments received by the public, the Redevelopment Authority of the County of Monroe, will submit said budget modification documentation to the Pennsylvania Department of Community and Economic Development (PA-DCED) for review.

The Monroe County Administrative building is accessible to handicapped persons. Persons requiring special accommodations, individuals with special needs, hearing, visual impairments, and non-English speaking for participation in this public hearing are urged to contact the County.
