ORDINANCE NO. 1352

**AN ORDINANCE AMENDING CHAPTER 150 – VEHICLES AND TRAFFIC, ARTICLE III – PARKING REGULATIONS, SECTION 26.3 BOROUGH PARKING LOTS, ARTICLE VIII – SCHEDULES, SECTION 72, SCHEDULE XX: PARKING METER ZONES OF THE EAST STROUDSBURG BOROUGH CODE OF ORDINANCES.**

BE IT ORDAINED by the Borough Council of the Borough of East Stroudsburg that Chapter 150 of the East Stroudsburg Code of Ordinances is hereby amended to include as follows:

**§ 150.26.3 Borough Parking Lots**

Borough parking lots or portions thereof not designated for metered parking, long-term lease (reserved) parking. In these parking areas, however, no person shall park a vehicle or allow the same to remain parked between the hours of 2:00 a.m. to 6:30 a.m. every day of the week without a long-term lease permit.

**§150.72 Schedule XX: Parking Meter Zones**

- A. Rates for parking. The Borough Council of the Borough of East Stroudsburg may, by resolution, from time to time, revise and change parking rates and determine the length of time that parking is permissible in any individual parking space which is regulated by the meter immediately adjacent thereto; and notice thereof shall be given to the public, stating the length of time during which parking is permitted and the conditions regulating the same, by either placing said notice on the parking meter or in the immediate vicinity of said parking facility.
- B. Parking meter zones and municipal parking lots are hereby established upon and along the following streets. It shall be unlawful to park a vehicle or to allow the same to remain parked therein for longer than the time limits prescribed. The time limit starts from the time the vehicle was initially parked in the space. Once the time limit has elapsed, the vehicle must vacate that parking space.
- C. Municipal parking lots without a permit.

<b>Lot Number</b>	<b>Time Limit</b>
Lot 1 (formerly Day Street Lot)	10 hours and 3 hours
Lot 2 (formerly Harlacher Lot)	10 hours and 3 hours
Lot 3 (formerly South Courtland Lot)	3 hours
Lot 4 (formerly South Kistler Lot)	10 hours and 3 hours
Lot 5 (North Kistler)	10 hours

D. No person shall park a vehicle or allow the same to remain parked in any of the on-street or off-street parking areas described above between the hours of 2:00 a.m. to 6:30 a.m. every day of the week without a permit.
