- The Borough provides a barricade with illuminated warning light to the person applying for the dumpster permit, for use in satisfying the requirements of Section 134.27 H.3 (warning of oncoming traffic), the advanced deposit fee shall be \$150.00.
- The parking/service fee as provided in Section 134-26 C shall be \$15.00 per day that a dumpster is placed in a metered parking place or other place that generates parking revenue for the Borough.
- No dumpster, whether placed at a metered parking space or anywhere within a public right-of-way, may remain in that space for more than 10 calendar days. Any person who maintains a dumpster at a given location for a period exceeding 10 calendar days shall be fined at the rate of \$10.00 per day.
