ORDINANCE NO. 1335

**AN ORDINANCE AMENDING CHAPTER 134-SOLID WASTE; ARTICLE I-GARBAGE COLLECTION AND DISPOSAL; ARTICLE II-RECYCLING; ARTICLE IV-REGULATION OF DUMPSTERS WITHIN PUBLIC RIGHT-OF-WAYS AND ARTICLE V-BOROUGH-OWNED TRASH RECEPTACLES; OF THE EAST STROUDSBURG BOROUGH CODE OF ORDINANCES.**

BE IT ORDAINED by the Borough Council of the Borough of East Stroudsburg that Chapter 134, Articles I, II, IV and V of the East Stroudsburg Code of Ordinances is hereby amended to include as follows:

**§ 134-8 Notice of Ordinance Violation; Payment.**

Upon the discovery of any violation under the terms of this Chapter, the Borough shall, through its authorized agents, issue a ticket and assess a fine to the Owner of a violation hereunder, either by personal delivery to such owner, by United States mail directed to the last-known address of such person or persons, as shown in the real estate registry records of the municipality, or by posting the same on the premises where such violation occurs.

If such person shall, within seven days after the delivery, mailing or posting of such notice, pay to the Treasurer of the municipality the sum of \$50 for the violation, the same will constitute full satisfaction for the violation noted in said notice. Tickets will be issued every 24 hours until the violation is abated or the solid waste is collected via regularly scheduled municipal collection and the fine will be increased by \$25 for each subsequent violation. The failure of such person to make payment, as aforesaid, within 7 days shall render such owner and/or occupant subject to the penalties as provided for in Section 134-7 above.

**§ 134-16 Notice of Ordinance Violation; Payment.**

Upon the discovery of any violation under the terms of this Chapter, the Borough shall, through its authorized agents, issue a ticket and assess a fine to the Owner of a violation hereunder, either by personal delivery to such owner, by United States mail directed to the last-known address of such person or

persons, as shown in the real estate registry records of the municipality, or by posting the same on the premises where such violation occurs.

If such person shall, within seven days after the delivery, mailing or posting of such notice, pay to the Treasurer of the municipality the sum of \$50 for the violation, the same will constitute full satisfaction for the violation noted in said notice. The failure of such person to make payment, as aforesaid, within 7 days shall render such owner and/or occupant subject to the penalties as provided for in Section 134-15 above.

**§ 134-29 Notice of Ordinance Violation; Payment.**

Upon the discovery of any violation under the terms of this Chapter, the Borough shall, through its authorized agents, issue a ticket and assess a fine to the Owner of a violation hereunder, either by personal delivery to such owner, by United States mail directed to the last-known address of such person or persons, as shown in the real estate registry records of the municipality, or by posting the same on the premises where such violation occurs.

If such person shall, within seven days after the delivery, mailing or posting of such notice, pay to the Treasurer of the municipality the sum of \$50 for the violation, the same will constitute full satisfaction for the violation noted in said notice. The failure of such person to make payment, as aforesaid, within 7 days shall render such owner and/or occupant subject to the penalties as provided for in Section 134-28 above.


**§ 134-35 Notice of Ordinance Violation; Payment.**

Upon the discovery of any violation under the terms of this Chapter, the Borough shall, through its authorized agents, issue a ticket and assess a fine to the Owner of a violation hereunder, either by personal delivery to such owner, by United States mail directed to the last-known address of such person or persons, as shown in the real estate registry records of the municipality, or by posting the same on the premises where such violation occurs.

If such person shall, within seven days after the delivery, mailing or posting of such notice, pay to the Treasurer of the municipality the sum of \$50 for the violation, the same will constitute full satisfaction for the violation noted in said notice. The failure of such person to make payment, as aforesaid, within 7 days shall render such owner and/or occupant subject to the penalties as provided for in Section 134-34 above.
