November 19, 2019 Minutes

A motion was made by Mr. Molin and seconded by Mr. Cross, to approve the November 19, 2019 minutes. The motion carried unanimously.

Public Hearing

Ordinance 1357, amending the Code of the Borough of East Stroudsburg, Chapter 126 – Sewers of the Borough of East Stroudsburg Code of Ordinances.

A motion was made by Mr. Molin and seconded by Mr. Flory to recess the regular meeting. The motion carried unanimously.

A motion was made by Mr. Molin and seconded by Mr. Flory to enter exhibit 1, Copy of Ordinance, exhibit 2, Proof of Publication, and exhibit 3, Sign in sheet, into evidence. The motion carried unanimously.

Mr. Bond advised the Zoning Ordinance Review Committee and the engineers reviewed the old ordinance in order to update it and change numerous definitions to be consistent with the current water ordinance. Mr. Scott reviewed the proposed changes to Chapter 126 – Sewer. This ordinance has not been updated in over ten years. Some of the proposed changes include revisions to the rate structure, simplifying the calculation and administration of sewer bills, defining various classifications of sewer customers, phasing out Metric Units and begin using English Standard Units, and setting rates to increase sewer revenues. With these proposed changes, the projected revenue target is a \$600,000.00 increase in annual revenues (over current) in 2020. Mr. Prevoznik stated that sewer revenues can be spent on operating maintenance, replacing aging equipment, capital improvements within the sewer system, but not to offset liabilities. Mr. Reese asked about the timeframe for new meters to be installed. Mr. Scott advised the borough is reviewing proposals on meters and could conceivably start in 2020. The project will have to be done in phases as this is a major capital improvement. Mr. Scott clarified that the homeowner is responsible for the service line from the main to the house.

With no questions from the public, a motion was made by Mr. Flory and seconded by Mr. Cross to close the public hearing and reconvene the regular meeting. The motion carried unanimously.

A motion was made by Ms. Flory and seconded by Mr. Cross to approve Ordinance No. 1357 amending the Code of the Borough of East Stroudsburg, Chapter 126 – Sewers of the Borough of East Stroudsburg Code of Ordinances, as presented and advertised. The motion carried unanimously.
