# MINUTES FOR REGULAR MEETING EAST STROUDSBURG BOROUGH COUNCIL TUESDAY FEBRUARY 16, 2021 - 7:15 p.m.

PRESENT IN PERSON: William T. Reese; Sonia Wolbert; Maury Molin; Don Cross; Roger DeLarco; Carrie Panepinto; Borough Manager Brian Bond. Also present were: Solicitor John Prevoznik; Zoning Officer Marv Walton; Public Works Director Brian Ace; and Borough Engineer Russ Scott

The Pledge of Allegiance was recited.

# Solicitor's Report on Executive Session

The Solicitor reported that an Executive Session was held on February 16, 2021 at 6:20 p.m., prior to the start of the Council Meeting. The Solicitor reported that the first part of Executive Session held with just council members, without Brian Bond, to discuss employee evaluations and evaluation forms. Mr. Bond rejoined the group and following topics were discussed and no decisions were made: a potential litigation resulting from a contractual matter; and property acquisition which may result in a condemnation. Executive Session ended at 7:10 p.m.

# February 2, 2021 Council Minutes

A motion was made by Mr. Molin and seconded by Mr. Cross to approve the minutes of the February 2, 2021 council meeting. The motion carried unanimously.

### Public Hearing - Ordinance 1375, Zoning 157-100.8, Wireless Communications

A motion was made by Ms. Panepinto and seconded by Mr. Molin to recess the regular meeting and convene the public hearing. The motion carried unanimously.

The proposed ordinance sets forth definitions regarding wireless communications and Provides Purposes and Findings of Fact; Provides for General Requirements for All Tower-Based Wireless Communications Facilities; Provides for Regulations for all Non-Tower Wireless Facilities Outside the Rights-of-Way; Provides Regulations Applicable to All Small Wireless Communications Facilities; Provides for Design Standards Applicable to All Small Wireless Communications Facilities; Provides for Violations Applicable to All Wireless Facilities; Provides for Insurance and Indemnification of Wireless Facilities; Provides for the Borough's Police Powers and sets forth a Severability Clause and the Effective Date of the Ordinance. Additionally, the ordinance amends the Table of Use Regulations found in Section 157-35 of the Code to set forth Tower Based WCF's, Non-Tower WCF's, Small WCF's-Collocated and Small WCF's Requiring Installation of New Wireless Support Structure as either Permitted or Special Exception Uses, depending in which zoning district the property is located.

Mr. Walton testified that the existing Borough Ordinance regarding telecommunications equipment is obsolete and unable to effectively regulate the newer technology of DAS and small cell technologies. He noted that existing Section 157-100.8 was approved in 2007. The existing Ordinance regulates tower-based technology. Since then, the telecommunication industry has moved away from large tower-based facilities to small wireless facilities usually located on existing buildings, poles, or new poles. This technology is usually located in the public right-of-way. The Borough's existing Ordinance was not written with this type of technology in mind. The proposed ordinance requires all Small Wireless Communications Facilities (SWCF) be Permitted Uses in all Zoning Districts if an SWCF is a facility on which the antenna structure

will be less than 50' in height, among other technical requirements. Meanwhile, all Tower Based Wireless Communications Facilities (Tower-based WCF) are a Special Exception in the C-1, C-1A, C-2, OM-1, S-1, I-M, and I-E Zoning Districts, and Non-Tower Wireless Communications Facilities (Non-Tower WCF), which are non-tower based facilities that do not meet the definition of a Small Wireless Communications Facility, are a Special Exception in the C-1, C-1A, C-2, OM-1, S-1, I-M, I-U, I-UA, and I-E Zoning Districts.

During the hearing, the following seven exhibits were entered into evidence without objection: Copy of the Ordinance (B1); Public Notice (B2); Proof of Publication (B3); Recommendation letter from East Stroudsburg Borough Planning Commission (B4); Recommendation letter from Monroe County Planning Commission (B5); Sign In Sheet (B6).

Solicitor Prevoznik asked Council if it had any questions of Mr. Walton. It was noted that the Wireless Ordinance took approximately three years to complete and was reviewed multiple times by East Stroudsburg Borough and Monroe County Planning Commissions. Borough Council had no questions. Solicitor Prevoznik asked whether any members of the public had any questions and, if so, to sign in on the public sign-in sheet (Exhibit B7). No member of the public requested to participate in the ordinance hearing. Solicitor Prevoznik asked for a motion to enter Exhibits B1 through B7 into evidence.

A motion was made by Mr. Cross and seconded by Mr. Molin to enter exhibits B1 through B7 into evidence. The motion carried unanimously.

A motion was made by Mr. Molin and seconded by Mr. Cross to close the public hearing and reconvene the regular meeting. The motion carried unanimously.

A motion was made by Mr. Cross and seconded by Mr. Molin to approve Ordinance No. 1375, amending Chapter 157, Zoning, 157-100.8, Wireless Communications, as advertised. The motion carried unanimously.

# Resolution 10-2021, Establishing the East Stroudsburg Borough Wireless Communications Facilities Fee Schedule

The following fees are hereby established, pursuant to Part II, Chapter 157, 157-100.8, East Stroudsburg Wireless Communications Facility Ordinance No. 1375 of 2021: Applications for Tower-Based WCF: \$2,500.00; Applications for Non-Tower WCF: \$1,000.00; Small WCF (collocated): \$500.00 for up to five small WCFs in a single application; \$100 for each small WCF thereafter in same application; and application for small WCF (requiring new wireless support structure): \$1,000.00. Annual Fees: \$270.00 for Small WCF (inside row).

A motion was made by Mr. Molin and seconded by Mr. Cross to approve Resolution 10-2021, Establishing the East Stroudsburg Borough Wireless Communications Facilities Fee Schedule, as presented. The motion carried unanimously.
