# MINUTES FOR REGULAR MEETING EAST STROUDSBURG BOROUGH COUNCIL TUESDAY JULY 20, 2021 - 7:15 p.m.

## **Solicitor's Report on Executive Session**

The Solicitor reported that an Executive Session was held on July 20, 2021 starting at 6:18 p.m., prior to the start of the council meeting; all members of Council were present; Mayor Martinelli was not present; also present were Mr. Bond and Mr. Prevoznik. The following matters were discussed: Personnel matters pertaining to job descriptions; a litigation filed in the Court of Common Pleas of Monroe County and a possible resolution thereof; and legal issues to be raised in an appeal to a litigation matter. Executive Session ended at 7:13 p.m. No decisions were made.

Mr. Bond reported that he is still waiting to hear back from Chuck Leonard regarding the status of grant funding for the demolition project.

## **Police Report:**

The SARPD report was distributed via email. Captain Gasper reported that he recently attended a meeting with a noise expert. At the meeting, the State law pertaining to fireworks within municipalities was a topic of discussion. Captain Gasper stated that the SARPD receives many

fireworks calls throughout the year. He further said that it is very difficult for the officers to enforce the fireworks law as written. He suggested that the municipalities write a letter to the State representatives requesting the fireworks law be revised to either remove the lawful use of fireworks or to change the law to allow property owners on which fireworks are illegally discharged be held responsible.

A motion was made by Mr. DeLarco and seconded by Mr. Molin to authorize the Borough Manager to write letters to the East Stroudsburg legislative representatives requesting they review the current fireworks State law and amend it to allow for better enforcement. The motion carried unanimously.

Mr. Walton provided an update on a few properties within the Borough.

The codes officers have issued 13 violation notices to 7 Roller Street in the past two years. Eight of the violations resulted in citations due to non-payment of the original violation. All of those citations have resulted in a guilty verdict or a guilty plea by the property owner.

The codes officers have issued six property violations to 338 Race Street over the past few years. To date, five violations have been paid. The outstanding ticket will be cited for non-payment. Mr. Walton also issued a Notice of Violation to this property on May 11, 2021 for operating a commercial business in a residential zone. A citation was issued on July 1, 2021 for failure to obtain a residential rental license.

## **Maury Molin:**

## Solicitor John Prevoznik, Esq.:

Mr. Prevoznik requested approval to enter into a settlement stipulation in the case of East Stroudsburg School District vs. M&M Ventures, Monroe County Board of Assessment Revision, Monroe County, and East Stroudsburg Borough, docketed to No. 008357-CV-2015. This settlement was presented to Mr. Prevoznik by Mr. Brown, who represents the East Stroudsburg School District, on July 19, 2021. Mr. Prevoznik stated that the execution of the Settlement Stipulation is time-sensitive. The settlement states that M&M Ventures agrees to the assessed millage rate for the years 2016 through 2020. For that same time period, M&M Ventures will owe the Borough of East Stroudsburg an additional sum of \$11,010.23 in taxes. Payment of the additional taxes will be one-half of the money owed to be paid within 60 days of the execution of the Settlement Stipulation, and the other one-half of the taxes to be paid by August 1, 2022. In addition, the Settlement Stipulation sets the assessed value for the M&M Ventures property for tax year 2020 and beyond at \$1,465,250.00 compared to the 2019 assessed value of \$280,176.00.
