The motion carried 3-0, with 2 abstentions (Yea: Ms. Wolbert, Ms. Panepinto, Mr. Reese; Abstain: Mr. Freeborn, Ms. Huber, as they were not present at the December 14, 2021 Council meeting).

December 21, 2021 Special Council Minutes

A motion was made by Ms. Panepinto and seconded by Ms. Wolbert to approve December 21, 2021 Special Council meeting minutes. The motion carried 3-0, with 2 abstentions (Yea: Ms. Wolbert, Ms. Panepinto, Mr. Reese; Abstain: Mr. Freeborn, Ms. Huber, as they were not present at the December 14, 2021 Council meeting).

Recycling Committee Report: Mr. Reese reported that the 2022 Twin Boro's Recycling Budget was approved.

Solicitor John Prevoznik, Esq.:

Manager's Report:

A motion was made by Mr. Freeborn and seconded by Ms. Panepinto to approve Resolution 4-2022, appointing Sharon J. Gerberich as Deputy Tax Collector, contingent upon taxing authorities and Surety Company approval. The motion carried unanimously.

Resolution 5-2022, Authorizing Transfer of Funds for Budget Purposes in Connection with Twin Boroughs Recycling for the Calendar Year 2021

A motion was made by Mr. Freeborn and seconded by Mr. Reese directing the Borough Manager to amend Resolution 5-2022, adding the amount of \$18,740.00, which is the amount the Borough of East Stroudsburg paid for the new recycling truck. The motion carried unanimously.

A motion was made by Mr. Reese and seconded by Mr. Freeborn to approve Resolution 5-2022, authorizing budget line item transfers specified in the resolution of the Twin Boro's Fund, with the amendment previously approved, of the Borough of Stroudsburg. The motion carried unanimously.

Resolution 6-2022, Authorizing a Budget Line Item Transfer of the Sewer Fund

A motion was made by Mr. Freeborn and seconded by Mr. Reese directing the Borough Manager to amend Resolution 6-2022, correcting the amount of the transfer to \$3,000.00 (erroneously typed on resolution as \$3,00.00). The motion carried unanimously.

A motion was made by Mr. Freeborn and seconded by Ms. Panepinto to approve Resolution 6-2022, authorizing a budget line item transfer of the Sewer Fund for the purchase of Sewer Jetter Nozzles, with the amendment previously approved. The motion carried unanimously.

A motion was made by Ms. Panepinto and seconded by Mr. Reese to approve the 2021 Shade Tree Commission Report and attach to the minutes. The motion carried unanimously.

A motion was made by Ms. Panepinto and seconded by Mr. Reese to approve renewing the annual contract with Granicus for short-term rental monitoring within the Borough at a cost of \$2,655.30. The motion carried unanimously.

A motion was made by Mr. Freeborn and seconded by Ms. Huber to authorize the Manager to sing the Pennsylvania Intrastate Allocation, the Janssen Participation, and the Pennsylvania Distributor Participation forms on behalf of the Borough. The motion carried unanimously.

A motion was made by Mr. Freeborn and seconded by Ms. Panepinto to authorize the advertising of the Fair Housing Act. The motion carried unanimously.

A motion was made by Mr. Freeborn and seconded by Mr. Reese to table the request from the Monroe County Historical Association to be a sponsoring member at the cost of \$250.00. This expense is not in the budget. The motion carried unanimously.

Approval of Warrant List 220103

A motion was made by Ms. Panepinto and seconded by Ms. Huber to approve Warrant List 220103 as presented. The motion carried unanimously.

Executive Session

A motion was made by Ms. Panepinto and seconded by Mr. Reese to go into Executive Session at 8:54 p.m.

A motion was made by Mr. Reese and seconded by Ms. Panepinto to reconvene the regular meeting at 9:40 p.m.

The Solicitor reported that all members of council were present with the exception of Mr. Molin. Mayor Brozusky was also present. The Borough Manager was present during the discussion of the Collective Bargaining Agreement. The Borough Manager was not in attendance during the discussion of personnel matters. No decisions were made.
