ORDINANCE NO. 1392

AN ORDINANCE AMENDING CHAPTER 150 – VEHICLES AND TRAFFIC, ARTICLE VIII, SCHEDULES, SECTION 68, SCHEDULE XVI, PARKING PROHIBITED AT ALL TIMES; SECTION 69, SCHEDULE XVII, PARKING PROHIBITED CERTAIN HOURS, OF THE EAST STROUDSBURG BOROUGH CODE OF ORDINANCES.

BE IT ORDAINED by the Borough Council of the Borough of East Stroudsburg that Chapter 150 of the East Stroudsburg Code of Ordinances is hereby amended to include as follows:

WHEREAS, the Borough is a Municipal Corporation of the Commonwealth of Pennsylvania, organized and existing under the Pennsylvania Borough Code, as amended, 8 Pa.C.S. §101, *et seq.*, (“Pennsylvania Borough Code”); and

WHEREAS, the East Stroudsburg Borough Council of the Borough of East Stroudsburg, pursuant to the Pennsylvania Borough Code, §1202 (Specific powers) (5) (make Regulations for Health, Welfare, and Safety of the Borough), (31) (iii) (to regulate parking and provide parking accommodations to promote the convenience and protection of the public); and

NOW THERFOR BE IT ORDAINED by the Borough Council of the Borough of East Stroudsburg that Chapter 150, Article VIII, Schedule XVI, Schedule XVII, of the East Stroudsburg Code of Ordinances is hereby amended to include as follows:

§150.27 A. Penalties for Parking Violations.

The addition of the Following:

Parking in a Non-Borough Approved Parking Area, Fine: \$15.00, Late Fee: \$25.00.

§150.68 Schedule XVI: Parking Prohibited at All Times shall be amended as follows:

Borough Street	South	From Day street to a point 28 feet west

§150.69 Schedule XVII: Parking Prohibited Certain Hours shall be repealed and replaced with a new Schedule XVII: Parking Prohibited Certain Hours as follows:

Normal Street	South	12:00 a.m. to 7:00 a.m.	Prospect Street to Hill Street
Penn Street	East	12:00 a.m. to 7:00 a.m.	Entire Length
Spangenburg Avenue	South	Thursday 8:00 a.m. to 6:00 p.m.	Entire length
Spangenburg Avenue	North	All except Thursday 8:00 a.m. to 6:00 p.m.	Entire length

SECTION 2. Severability. It is hereby declared to be the legislative intent

that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid or ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other parts and provisions of this Ordinance shall continue to be separately and fully effective. The Borough Council hereby declares that it would have passed this Ordinance and each section or part thereof, other than any part declared invalid, if it had advance knowledge that any part would be declared invalid.

SECTION 3. Savings. All provisions of Section 150.27; Section 150.58 and Section 150.68 shall remain in full force and effect and incorporate full herein as if set forth in their entirety.

SECTION 4. Repealer. Any specific provisions of the East Stroudsburg Borough Code that are in direct conflict within this Ordinance are hereby repealed.

SECTION 5. Effective Date. This Ordinance shall be effective upon its approval as provided by law.
