ORDINANCE NO. 1393

**AN ORDINANCE AMENDING CHAPTER 151, VEHICLES,
PARKING; ARTICLE I, RESIDENTIAL PERMIT PARKING
OF THE EAST STROUDSBURG BOROUGH CODE OF
ORDINANCES.**

WHEREAS, the Borough is a Municipal Corporation of the Commonwealth of Pennsylvania, organized and existing under the Pennsylvania Borough Code, as amended, 8 Pa.C.S. §101, *et seq.*, (“Pennsylvania Borough Code”); and

WHEREAS, the East Stroudsburg Borough Council of the Borough of East Stroudsburg, pursuant to the Pennsylvania Borough Code, §1202 (Specific powers) (5) (make Regulations for Health, Welfare, and Safety of the Borough), (31) (iii) (to regulate parking and provide parking accommodations to promote the convenience and protection of the public); and

NOW THEREFOR BE IT ORDAINED by the Borough Council of the Borough of East Stroudsburg that Chapter 151, Article I of the East Stroudsburg Code of Ordinances is hereby amended to include as follows:

SECTION 1. Chapter 151, Article I of the Code of the Borough of East Stroudsburg, Residential Permit Parking., is hereby amended as follows:

§151-3.A is amended as follows:

There are three areas designated as residential permit parking districts, designated as "Blue". "Yellow" and “Green” Permit Parking Districts. Permit holders are only permitted to park in the area that corresponds with the color of their permit decal during the hours that the residential permit parking restrictions are in effect

§151-3.B. is amended as follows:

The “Blue” Permit Parking District adding the following streets or roads: Marguerite Street (Normal Street to Spangenburg Avenue and East Brown to Emerson Road), Spangenburg

§ 151-3.D is added as follows:

The "Green" Permit Parking District contains the following streets or roads: Maple Avenue, Grove Street, Elizabeth Street (from West Vine Street to West Broad Street) and Walnut Street (from West Vine Street to Gold Street).

SECTION 2. Severability. It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid or ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Ordinance shall continue to be separately and fully effective. The Borough Council hereby declares that it would have passed this Ordinance and each section or part thereof, other than any part declared invalid, if it had advance knowledge that any part would be declared invalid.

SECTION 3. Savings. All provisions of Section 151.3 shall remain in full force and effect and incorporate full herein as if set forth in their entirety

SECTION 3. Repealer. Any specific provisions of the East Stroudsburg Borough Code that are in direct conflict within this Ordinance are hereby repealed.

SECTION 4. Effective Date. This Ordinance shall be effective upon its approval as provided by law.
