MINUTES FOR REGULAR MEETING EAST STROUDSBURG BOROUGH COUNCIL TUESDAY, DECEMBER 20, 2022 – 6:00 p.m.

December 6, 2022 Council Minutes:

A motion was made by Mr. Freeborn and seconded by Ms. Huber to approve the Minutes of the December 6, 2022 Council meeting. The motion carried unanimously.

December 13, 2022 Special Council Minutes:

A motion was made by Mr. Freeborn and seconded by Ms. Huber to approve the Minutes of the December 13, 2022 Special Council meeting. The motion carried unanimously.

Conditional Use Hearing, Amerco Real Estate Company, U-Haul, U-Box Storage Facility:

Tom Josiah, the Borough's accountant, will determine if the funds are permissible to transfer to the ECA, which is also a 501(c)(3).

Engineer's Report:

Water Plant Repairs:

A motion was made by Mr. Freeborn and seconded by Mr. Reese to accept the lowest responsive quote for Sedimentation Tank #1 Beam Spall Repair from R.W. Masten, Jr., as submitted November 15, 2022, in the amount of \$4,680.00. The motion carried unanimously.

A motion was made by Mr. Freeborn and seconded by Mr. Reese instructing the Borough Engineer to add the action items from the Memorandum, dated December 20, 2022, on the Engineer's Report and keep them on the report until each item is satisfied. The motion carried unanimously.

A motion was made by Ms. Huber and seconded by Mr. Reese instructing the Borough Manager to add a motion to the January 3, 2023 Council Meeting Agenda, to authorize the Borough Engineer to develop a Preventative Maintenance Schedule for the Water Treatment Plant. The motion carried unanimously.

Water Meter Replacement Program Update:

This proposal amount is unchanged from the 2022 authorization. The motion carried unanimously.

<u>Public Hearing, Ordinance 1399, Chapter 150 Vehicles and Traffic, Article VIII, Schedules, Section 69, Schedule XVII, Parking Prohibited certain hours, of the East Stroudsburg</u> Borough Code of Ordinances:

A motion was made by Mr. Reese and seconded by Ms. Panepinto to recess the regular meeting and convene the Public Hearing for Ordinance 1399. The motion carried unanimously.

Mr. Bond explained this ordinance changes the parking restrictions on a section of Borough Street. There were no questions from Council or the public.

A motion was made by Ms. Panepinto and seconded by Mr. Freeborn to close the public hearing and reconvene the regular meeting. The motion carried unanimously.

A motion was made by Ms. Huber and seconded by Mr. Freeborn to approve the East Stroudsburg Borough Budget for the Year 2023, as presented, with two *de minimis* changes to the total year expenses reflect that of 2023 instead of 2018. The motion carried unanimously.

Public Hearing, Ordinance 1398, Fixing the Real Estate Tax Rate for the Year 2023:

A motion was made by Mr. Freeborn and seconded by Mr. Reese to recess the regular meeting and convene the Public Hearing for Ordinance 1398. The motion carried unanimously.

Mr. Bond explained the 2023 Real Estate Tax Rate is proposed to be 5.1747 mills, which is approximately a 15% increase from 2022.

With no questions from members of Council or the public, a motion was made by Ms. Huber and seconded by Mr. Freeborn to enter exhibits 1 through 3 into evidence. The motion carried unanimously.

A motion was made by Mr. Freeborn and seconded by Mr. Reese to approve Ordinance No. 1398, Fixing the Real Estate Tax Rate for the Year 2023, as presented. The motion carried unanimously.

Executive Session:

A motion was made by Mr. Freeborn and seconded by Ms. Panepinto to go into Executive Session at 9:18 p.m. The motion carried unanimously.

A motion was made by Ms. Huber and seconded by Mr. Reese to reconvene the meeting at 10:13 p.m. The motion carried unanimously.

Solicitor's Report on Executive Session:

The Solicitor reported that three personnel matters and two pending zoning enforcement issues were discussed. Mr. Freeborn left Executive Session at 10:02 p.m., at which time pending contractual negotiations regarding the Middle Dam were discussed. No decisions were made.

A motion was made by Ms. Panepinto and seconded by Ms. Huber to adjourn the meeting at 10:18 p.m. The motion carried unanimously.
