PROCEDURE FOR OBTAINING A DRIVEWAY/CURBING/SIDEWALK PERMIT

- 1. Fully complete the application for your permit making sure to date and sign it and return it along with the required application fee.
- 2. After the application has been approved, the applicant will be contacted when the permit is ready to be picked up. At pick up you will be asked to sign all copies of the permit and you will be given a check list with the inspection requirements for your project.
- 3. Permits are valid for one (1) year from date of issuance.
- 4. If you have any questions concerning your application, please contact the Director of Public Works at 570-421-8300, ext. 102. If no one is available when you call, please state what your call pertains to and leave a detailed message.
- 5. **PLEASE NOTE**: No construction may begin without paying for and receiving your approved permit. Performing work without a permit will result in the doubling of all permit fees.
- 6. All driveway/curbing/sidewalk construction must comply with the specifications provided when the permit is issued. All work must be inspected prior to pouring of concrete.

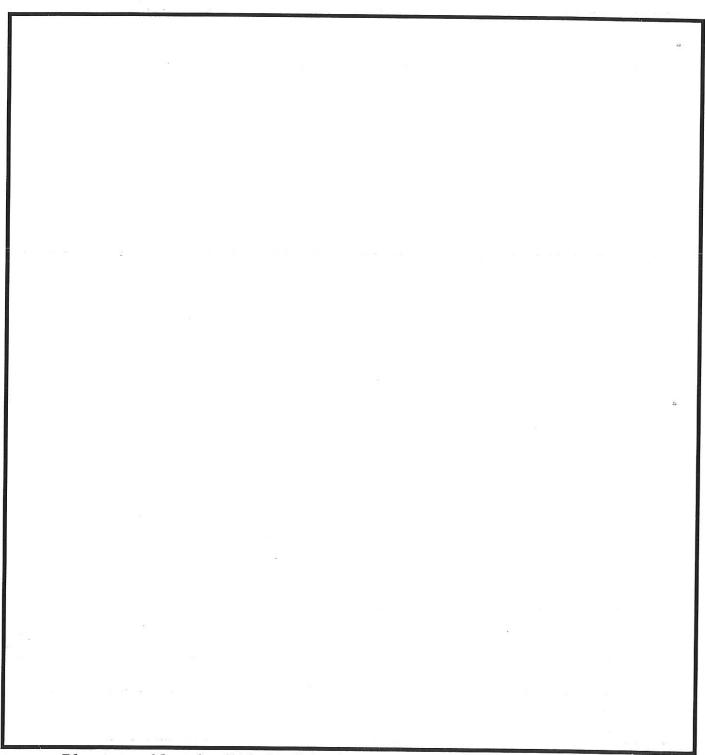

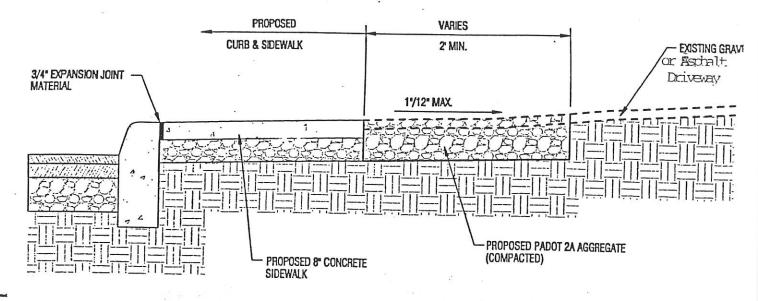

- 7. ANY ROAD RESTRICTION OR CLOSURE REQUIRES A TRAFFIC CONTROL PERMIT THIS IS A SEPARATE PERMIT FROM THE BOROUGH AND WILL REQUIRE TRAFFIC CONTROL DIAGRAMS, SITE SKETCHES, ETC. 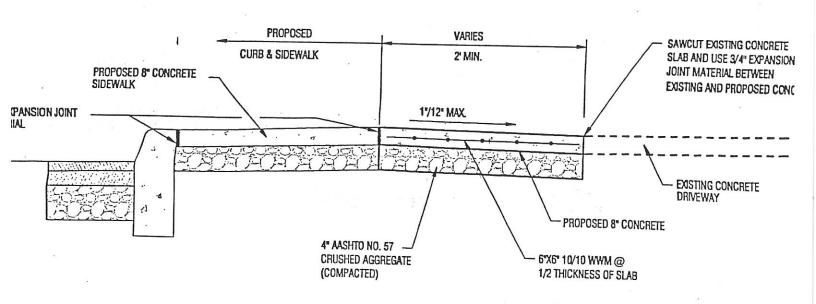

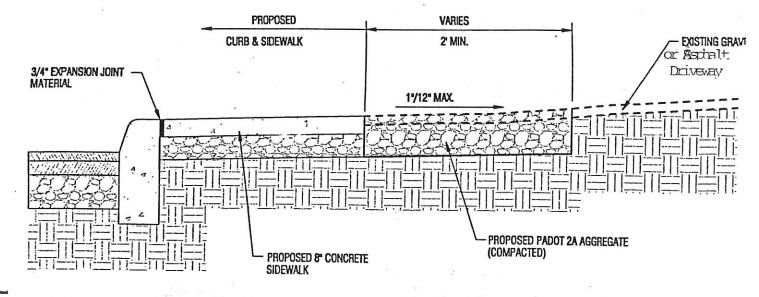

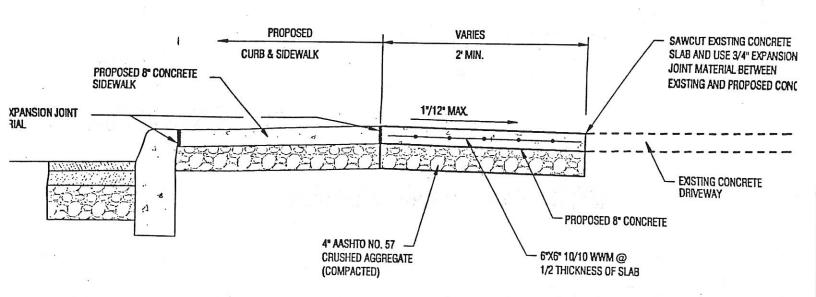
Asphalt or Gravel Drivevay Transition Detail (ON BACKSIDE OF SIDEWALK) N.T.S.



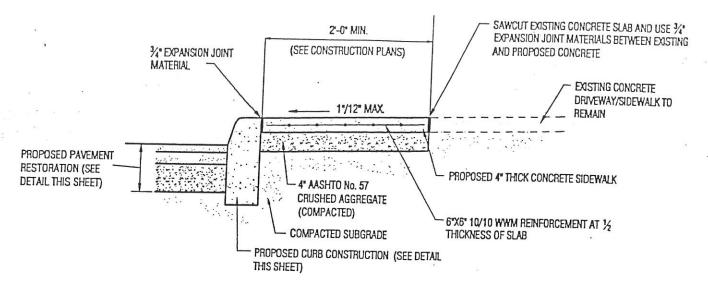
CONCRETE DRIVEWAY TRANSITION DETAIL (ON BACKSIDE OF SIDEWALK) N.T.S.

CONCRETE DRIVEWAY TRANSITION DETAIL (ON BACKSIDE OF SIDEWALK) N.T.S.

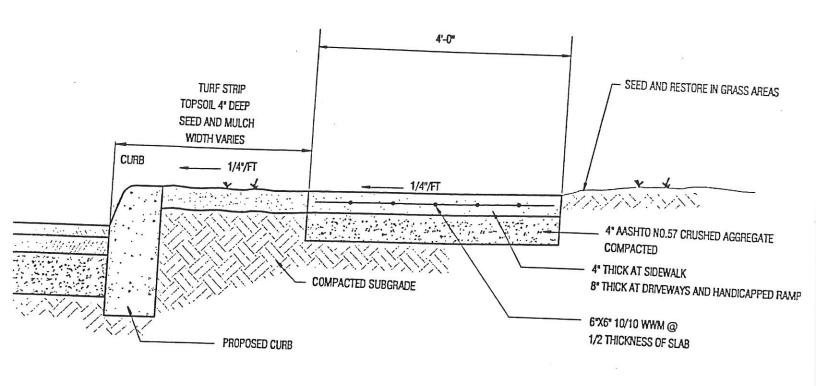


CONCRETE SIDEWALK TRANSITION DETAIL

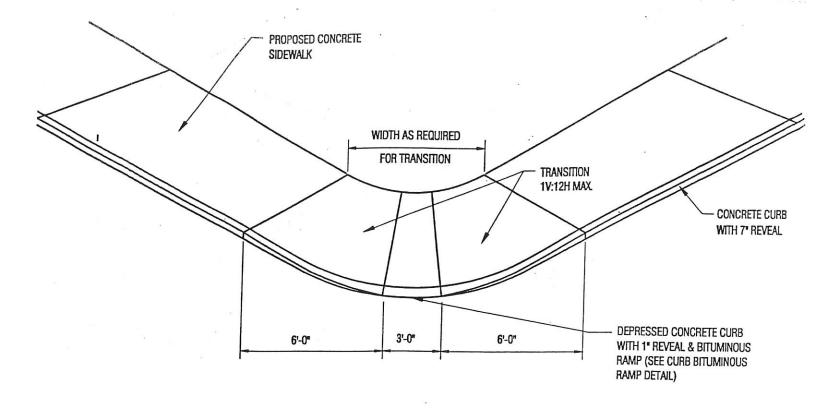

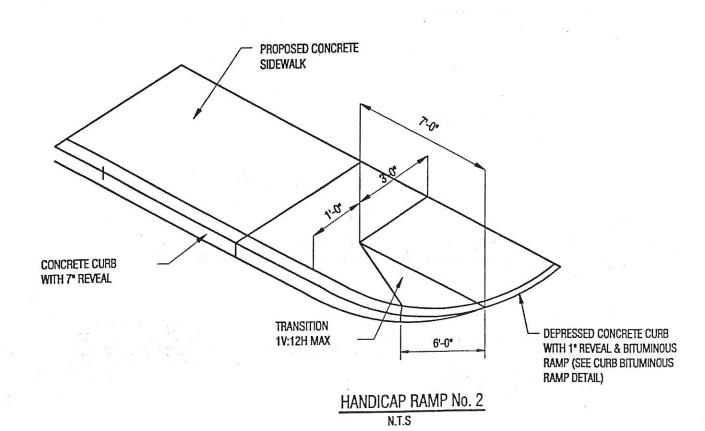
TYPICAL CURB/SIDEWALK DETAIL

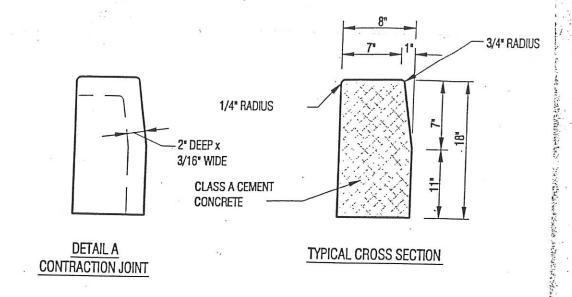

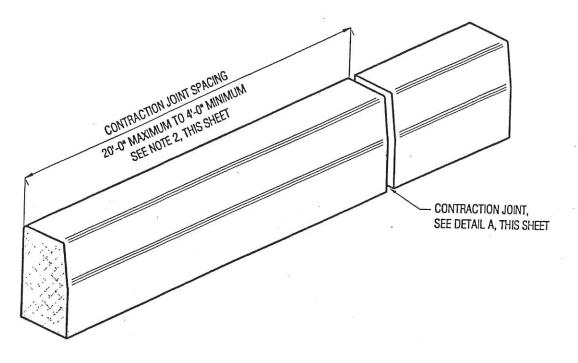

- CONCRETE SIDEWALK SHALL HAVE SCORED TRANSVERSE JOINTS EVERY 5 FEET AND TRANSVERSE EXPANSION JOINTS WITH 3/4" EXPANSION JOINT MATERIAL EVERY 20 FEET.
- PAVEMENT JOINT SEALER SHALL BE PLACED AT ALL FACE

- 2. SPACE CONTRACTION JOINTS IN UNIFORM LENGTHS OR SECTIONS.
- 3. PLACE 3/4 INCH PREMOLDED EXPANSION JOINT FILLER MATERIAL AT STRUCTURES AND AT THE END OF THE WORK DAY. CUT MATERIAL TO CONFORM TO AREA ADJACENT TO CURB OR TO CONFORM TO CROSS SECTIONAL AREA OF CURB.
