

**PUBLIC NOTICE:
Modification #1 Hearing FFY2023 CDBG**

THE COUNCIL OF THE BOROUGH OF EAST STROUDSBURG, PENNSYLVANIA, will hold a public hearing on **Tuesday, April 1, 2025, 7:00 pm** in the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg, Pennsylvania, 18301.

The Council of the Borough of East Stroudsburg is requesting a modification to the FFY 2023 CDBG Program. Proposed changes include the deletion of activity "Housing Rehabilitation" in the amount of \$129,302, and the addition of ADA Ramps & Curb Cuts for the same amount. This activity will create or repair 19 ADA Ramps & Curb Cuts at various locations throughout the Borough of East Stroudsburg.

This hearing is being held to provide information to the Borough residents on the proposed modifications to the FFY 2023 CDBG. Interested residents can discuss the proposed modification, present their views, and submit comments. Borough residents may also comment on the Borough's prior uses of CDBG funds.

Review of the proposed modification, and all public comments, must be submitted by Friday, April 11, 2025. **The Council of the Borough of East Stroudsburg will consider approval of the CDBG FFY2023 Modification #1 during their meeting on Tuesday, April 15, 2025 at 7:00 pm at the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg.**
