

PUBLIC NOTICE: Modification #2 Hearing FFY2023E CDBG

THE COUNCIL OF THE BOROUGH OF EAST STROUDSBURG, PENNSYLVANIA, will hold a public hearing on **Tuesday, June 3, 2025**, 7:00 pm in the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg, Pennsylvania, 18301.

The Council of the Borough of East Stroudsburg requests Modification #2 to the FFY 2023 CDBG Program. Proposed changes include deleting activity "Housing Rehabilitation" in the amount of \$129,302 and changing the previous modification, ADA Ramps & Curb Cuts project, to a Street Improvement Project in the same amount. This new activity will make paving improvements to Maple Avenue and Berwick Heights Road in the Borough of East Stroudsburg.

This hearing is being held to inform the Borough residents about the proposed modifications for the FFY 2023. Interested residents can discuss the proposed modification, present their views, and submit comments. Borough residents may also comment on the Borough's prior uses of CDBG funds.

The Council of the Borough of East Stroudsburg will consider approval of the CDBG FFY2023 Modification #2 during their meeting on Tuesday, June 17, 2025 at 7:00 pm at the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg.**
