

PUBLIC NOTICE: Modification #1 Hearing FFY2024E CDBG

THE COUNCIL OF THE BOROUGH OF EAST STROUDSBURG, PENNSYLVANIA, will hold a public hearing on **Tuesday, December 2, 2025**, at 7:00 pm in the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg, Pennsylvania, 18301.

The Council of the Borough of East Stroudsburg requests Modification #1 to the FFY 2024 CDBG Program. Proposed changes include deleting activity 58809, "Maple Avenue and Berwick Heights" Street Improvement Project, in the amount of \$126,927, and adding a new activity, "Day Street" Improvement Project, in the same amount. This new activity will make paving improvements to Day Street in the Borough of East Stroudsburg.

This hearing is being held to inform the Borough residents about the proposed modification for FFY 2024. Interested residents can discuss the proposed modification, present their views, and submit comments. Borough residents may also comment on the Borough's prior uses of CDBG funds.
