____ I/We understand that a Residential Rental License is valid for one annual calendar year, and each licensed regulated rental unit shall be subject to a minimum of one inspection every two years, based upon a schedule established by the CEO.

____ I/We understand that it is the responsibility of the owner(s)/manager to allow and schedule inspections by a CEO of the premises during Borough business hours, after a minimum of five calendar days' notice has been provided to the owner or manager. Owner/Property Manager must be present during the Residential Rental Inspection. Failing to allow entry/schedule an inspection requested by the CEO could result in fines, penalties and/or license suspension, revocation or denial as described by § 124 of the Code of the Borough of East Stroudsburg.
